

Level II: Brother James Philip Garrity, C.F.X. (Funds of \$250,000 or more)

THE ALFRED A. ALLGEIER '48 MEMORIAL ENDOWMENT

This endowment was established in the summer of 2011 by the estate of Alfred A. Allgeier, Class of 1948. Alfred was a very loyal supporter of St. X, and now his legacy will afford a young boy the opportunity to attend his most cherished alma mater. The use of these funds is restricted to allow Saint Xavier High School to provide tuition assistance to young men desiring a Xaverian Brothers education.

THE THOMAS BORDERS EXCELLENCE IN TEACHING ENDOWMENT

This endowment was established in December 1999, to provide funding for the Thomas Borders Excellence in Teaching Award. A \$7,500 cash award is presented annually in the spring at the Saint Xavier graduation ceremony to a teacher whose commitment to students and education is exemplary.

The endowment was increased in the spring of 2014 to establish the T. S. Borders Faculty Award and is designed to recognize a teacher with one to four years of experience at St. X who consistently demonstrates the talents, traits and potential that will further the legacy and philosophy of Xaverian Brothers' education at Saint Xavier High School. The recipient will receive \$2,500 that the Borders' hope will encourage a newer faculty member in his or her career choice and support the honoree's continued personal and professional growth as he or she gains expertise in professional practice.

THE MARY CATHERINE AND ROY W. DAVIS MEMORIAL ENDOWMENT

This endowment was established in the summer of 2008 by the estate of Mary Catherine Davis. The fund use is restricted to allow Saint Xavier High School to provide tuition assistance to young men desiring a Xaverian Brothers education.

THE RICHARD A. CHARRON†/BROTHER DEPAUL, C.F.X. (EDWIN XAVIER TRAVERS†) DISTINGUISHED FACULTY FELLOW

To be named a Charron-DePaul Distinguished Faculty Fellow, a member of the Saint Xavier High School English Department will have distinguished himself or herself as a master teacher and mentor to students, as well as being seen as an academic leader among their peers. To ensure

that this level of excellence will remain in the English Department, this endowment will support the compensation package of the Charron-DePaul Fellow. The endowment, the first distinguished faculty position in Saint Xavier's history, was established by Paul R. Charron, Class of 1960, as a tribute to his father, Richard A. Charron, a student of English literature and voracious reader who instilled the same interests in his son, and to Brother DePaul, C.F.X. (Edwin Xavier Travers), his English teacher, whose caring manner mentored and challenged him at Saint Xavier. This tribute to these two important men in Paul's life will serve as a reminder of the significant impact that parents and teachers have on the young men of Saint Xavier.

NEW-THE GRAESER ENDOWMENT

This endowment was established by Emil A. Graeser, II '48† and Nancy L. Graeser† in the summer of 2000. The purpose of the fund is to provide for the long-term financial needs of St. X. Funds may be applied toward tuition assistance (need-based) or as the school deems appropriate.

THE HENRY '46 AND JANICE HEIT MEMORIAL ENDOWMENT

The endowment was established in the winter of 2011 by David Heit '71 and will be used to provide need-based tuition assistance. Preference will be given to young men who will increase the diversity of Saint Xavier's student body, including those who may be physically handicapped.

THE HOECK ENDOWMENT

This endowment was established in the spring of 1997 by John '44 and Anne Hoeck. The purpose of this fund is to provide tuition assistance to needy young men, regardless of race, religion or nationality, who desire a Saint Xavier education.

THE ALBERT GRAY HORTON, II '88 MEMORIAL SCHOLARSHIP

This fund was established by the Horton family in April of 1993 to memorialize Gray for his special contribution as a member of the St. X family. Gray was a model student while at St. X and provided spirited leadership to his fellow classmates, as well as to the student body. The fund will support at least four Saint Xavier students with significant need-based awards to be applied to their tuition and are renewable each year.

BROTHER JAMES LEO MCCARTHY, C.F.X.† ENDOWMENT

This fund was established in 1996 by the Simon family in memory of Brother James McCarthy, C.F.X. Brother James served as a teacher and administrator at Saint Xavier for twenty-seven years and had a masterful way of stimulating his students and colleagues. The fund's purpose is to provide tuition assistance to needy young men, regardless of race, religion or nationality, who desire a Saint Xavier education.

THE CARL '45† AND ROSEMARY† MUELLER DISTINGUISHED FACULTY FELLOW

To be named a Mueller Distinguished Faculty Fellow, a member of the Saint Xavier High School Business and Technology Department will have distinguished himself or herself as a master teacher and mentor to students as well as being seen as an academic leader among

their peers. To ensure that the level of excellence will remain in the Business and Technology Department, this endowment will support the compensation package of the Mueller Fellow. This endowment, originally established by the Mueller family in the spring of 2000, became the second faculty fellow established at Saint Xavier in the spring of 2007.

THE ROSE†, CARL† AND ROSE MARIE† SUNDERHAUF ENDOWMENT

C. W. "Wally" Sunderhauf '44, in loving memory of his parents Rose and Carl, and his sister, Rose Marie, established this endowed scholarship. Wally had a great appreciation of his parents for the many blessings and opportunities afforded to him, and he held the relationship with his sister in a very special place. This endowment will provide tuition assistance for young men attending Saint Xavier High School and is open to students of any race, religion or nationality.

NEW-THE BERNARD F. THIEMANN '58† ENDOWMENT

This endowment was established in the winter of 2014 by the estate of Bernard F. Thiemann, Class of 1958. The use of these funds is restricted to allow Saint Xavier High School to provide tuition assistance to young men desiring a Xaverian Brothers education.

THE XAVERIAN CORNERSTONE ENDOWMENT

This fund, established by an anonymous challenge grant of \$100,000 in February of 1992, will help preserve the Xaverian charism by supporting both students and faculty. The challenge was also matched in February of the same year bringing the initial endowment balance to \$200,000. This endowment will allow Saint Xavier to maintain and attract qualified and caring teachers who share the Brothers' dedication to the values of Catholic education and to provide assistance to deserving families who desire the clear benefits of a Catholic education at Saint Xavier.
